NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, April 28, 2015, at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes to consider the following:

WESTERN AVENUE VISION PLAN: A review of the Western Avenue Vision Plan design guidelines being prepared for the City of Rancho Palos. Western Avenue is the primary N-S corridor of the South Bay, Peninsula, and San Pedro communities. The Cities of Rancho Palos Verdes and Los Angeles have teamed together to develop guidelines to implement a consistent and cohesive implementation tool for Western Avenue, with a goal to create an environment that invites mobility for various users and creates more inviting, business friendly destinations. This meeting supplements a public workshop that was held on March 14, 2015. The consultant has taken all comments into consideration and is presenting a draft document to the City of Rancho Palos Verdes Planning Commission for consideration. The updated Draft document will be available on the City's website (see below) by Monday, April 14, 2015. The City encourages all interested parties to submit written comments and attend the public hearing.
