NOTICE IS HEREBY GIVEN THAT the City of Rancho Palos Verdes has received an application for the following project:

**Case No. ZON2016-00051 (Special Use Permit):** A request to allow Las Candalistas, a non-profit organization, to utilize the Point View property located at 6001 Palos Verdes Drive South to hold their annual spring fundraiser on Thursday, April 28, 2016 between 9:30 AM and 3:00 PM. The request includes the following:

- Parking will be provided on site with additional parking provided at the City's Abalone Cove Park parking lot, where guests will be shuttled to the Point View property using the entrance off Palos Verdes Drive South.
- Event set-up will begin at 10:00 AM on Wednesday, April 27, 2016 and tear-down and clean-up will conclude by 5:00 PM on Friday, April 29, 2016.
- There will be 1 (40" x 60") canopy and 15 umbrellas with 35 round tables for guests, 19 pop-up tents for vendors and event staff with 8' long tables.
- Activities include lunch, speakers, a silent auction, displays, demonstrations, vendors, and food sales (baked and gourmet foods).
- Sound amplification for the event is proposed on April 28, 2016 between 10:30 AM and 1:30 PM.
- Approximately 400 guests are expected to attend this 1-day event.

Only those who have submitted written comments prior to the end of the notification period (4:30pm on Friday March 11, 2016) will receive notification of the decision and a copy of the Staff report supporting that decision. The Director's decision may then be appealed, in writing, to the Planning Commission. The appeal letter must set forth the grounds of the appeal and any specific actions requested by the appellant, and must be accompanied by the applicable fee.

The application and plans are on file with the Community Development Department at City Hall, 30940 Hawthorne Boulevard, Rancho Palos Verdes, and are available for review between the hours of 7:30 AM to 5:30 PM, Mondays through Thursdays, and from 7:30 AM to 4:30 PM on Fridays.
