NOTICE IS HEREBY GIVEN that the City's Hearings Officer of the City of Rancho Palos Verdes will conduct a public hearing on Wednesday, March 16, 2016 at 9:00 AM at the Community Development Department Conference Room, located at 30940 Hawthorne Blvd., Rancho Palos Verdes, to consider the following:

COASTAL PERMIT (CASE NO. ZON2016-00065): A request to install two (2) sets of Automated License Plate Reader (ALPR) Camera Systems within the City's public right-of-way, along the east and west bound lanes of Palos Verdes Drive West at their intersection with Lunada Drive. The ALRP Camera Systems will be installed in cabinets measuring 12"W x 16"L x 38"H.

LOCATION: **Public Right-of-Way, Palos Verdes Drive West & Lunada Vista**

PROPERTY OWNER: **City of Rancho Palos Verdes**

APPLICANT: **City of Rancho Palos Verdes**

Because the subject property lies within an **Appealable Area** of the City's Coastal Specific Plan District, the application requires approval of a Coastal Permit by the City's Hearings Officer (The Director of Community Development).

If you have any comments or concerns about the proposed project, please communicate those thoughts in writing to Octavio Silva, Associate Planner, by **March 10, 2016**. By doing so, you will ensure that your comments are taken into consideration for the Staff analysis of the project. Please note that written materials, including emails, submitted to the City are public records and may be posted on the City's website. Accordingly, you may wish to omit personal information from your written materials. Only those who submit written comments and/or give testimony at the public hearing (interested parties) will receive notification of the decision. The Coastal Hearing Officer's decision may then be appealed to the City's Planning Commission. The City's final decision on the application may ultimately be appealed to the State Coastal Commission.

If you would like the opportunity to review the proposed plans, they are on file in the Community Development Department at 30940 Hawthorne Boulevard, Rancho Palos Verdes, and are available for review from 7:30 AM to 5:30 PM Monday through Thursday, and from 7:30 AM to 4:30 PM Friday.
