NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a public hearing on **Tuesday, August 16, 2016, at 7:00 p.m.** at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes to consider:

**Revision “EEE” to the Trump National Golf Course Project:** which includes the following:

- A request to revise Grading Permit No. 1541, in order to amend the project's conditions of approval to allow the continued temporary opening of the driving range for an additional 2-year period.
- Development Agreement Revision: A Revision to the existing Development Agreement between Trump National and the City of Rancho Palos Verdes which would extend the life of the Development Agreement and Tentative Tract Map No. 50666 for an additional 2 years consistent with California State Government Code Section 66452.33, which through the Subdivision Map Act, automatically extends Tract Maps for an additional 2-year period.

**Location:**

Trump National Golf Course, One Ocean Trails Drive (south of the intersection of Palos Verdes Drive South and Forrestal Drive).

**Owner:** V.H. Property Corp.

All interested parties are invited to submit written comments and to attend and give testimony.
