

Minutes to the October 6, 2016 Preserve Management Meeting

Attending: Recreation & Parks Director Cory Linder, Public Works Maintenance Superintendent Sean Larvenz, Senior Administrative Analyst Matt Waters, Administrative Analyst/Open Space Manager Katie Lozano, Assistant Engineer James Flannigan, Recreation Supervisor David Pearce, PVPLC Executive Director Andrea Vona, L.A. Preserve Maintenance

- Active Preserve Projects: Engineer Flannigan and Supervisor Pearce reported that the Cal Water repair of the main line break on Burma Rd. is complete, and awaiting final inspection; the dewatering wells drilling operation is now operating at the first site along Ishibashi Farm Trail, but trail closures do not seem necessary at this time; the landslide survey work will be resuming next week; and Dave will inform him of the designated trails that vehicles may use; the SCE pole replacement project in the San Ramon Reserve is awaiting an encroachment permit from Public Works while the Filiorum Reserve pole replacement project requiring a helicopter is awaiting a Special Use Permit from Community Development.
- Review of Habitat Projects, Trail Projects and Maintenance: Executive Director Vona reported that the irrigation line installation at the Alta Vicente restoration site should be completed by the end of next week; Damian and PVPLC will be working mostly in Forrestal and Abalone Cove Reserves this month.
- Preserve Signage Plan: Director Mohan confirmed that City staff will approve final sign content once it is prepared.

Preserve Operations

- Review of Public Events in Preserve: Executive Director Vona reported that the PVPLC is having a couple of volunteer projects over the next two weekends including trail improvements on Zote's Cutacross Trail on Oct. 15th in the Filiorum Reserve.
- Review of Enforcement/Patrol/Education:
 - Sheriff's Report – Deputy Jimenez reported a number of warnings and citations issued since they started patrolling in July; the deputies are aware of the increased use of Burma Rd. and the overlook area by individuals in the Preserve after hours of operation; Deputy Kuwata reported that they will be addressing the homeless camp on the beach in the Vicente Bluffs area
 - OSM Report -- Supervisor Pearce passed out copies of the City Maintenance & Public Use logs and reported that Preserve Staff had over 2,007 public contacts in September and that the Staff has participated in 8 clean-up projects and one spur trail blockage in the Preserve this past month.
 - VTW Report – PVPLC presented a summary of the weekly reports.
