**PUBLIC NOTICE**

NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, January 24, 2017, at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes, to consider recommending to the City Council the following:

**Conditional Large Domestic Animal Permit Revision (ZON2016-00395):** A request to 1) extend the existing Conditional Large Domestic Animal Permit No. 5 by five additional years to continue the operations at the Portuguese Bend Pony Club; 2) extend the operating hours of small group activities from "daylight hours" to 8am to 8pm; 3) extend the operating hours for big groups from 8am to 5pm on Saturdays to 8am to 8pm on Saturdays; and 4) install four 10-foot tall flood lights with light hoods for arena lighting at two of the existing corrals on the property.
