NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, February 14, 2017, at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes to consider the following:

SITE PLAN REVIEW (CASE NO. ZON2017-00033): A request to construct a new swimming pool and spa with associated equipment, a 3' tall retaining wall (136' in length), and 19yd³ of associated grading (cut) in the rear yard.

LOCATION: 5933 Ocean Terrace Drive

PROPERTY OWNER: Justin Reese

APPLICANT: Steve Ragan

City Council Resolution No. 93-86 allows, among other things, certain at-grade uses outside the building grading restriction (BGR) line. Condition No. 3 of Resolution No. 93-86 states that outside the building grading restriction (BGR) line, the grading allowed for pools and/or in-ground spas shall be excavation only, with no associated retaining walls, unless a retaining wall, not exceeding three feet in height, is approved by the Planning Commission. Thus, the project as proposed requires consideration by the Planning Commission.

If you have any comments or concerns about the proposed project, please communicate those thoughts in writing to Amy Seeraty, by Tuesday, February 7, 2017. By doing so, you will ensure that your comments are taken into consideration for the Staff analysis of the project. All correspondence received after February 7, 2017 will be given separately to the Planning Commission on the night of the meeting. In addition, City meetings may be televised and may be accessed through the City's website. Accordingly, you may wish to omit personal information from your oral presentation or written materials as it may become part of the public record regarding an item on the agenda. Only those who have submitted written comments will receive notification of the decision.
