NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, March 14, 2017 at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes to consider recommending to the City Council the following:

**CONDITIONAL LARGE DOMESTIC ANIMAL PERMIT REVISION NO. 2 (CASE NO. ZON2016-00465):** A request to 1) extend the existing Conditional Large Domestic Animal Permit No. 2 for five additional years marking the new expiration date as December 19, 2021 to continue the operations of the "Ride-to-Fly" therapeutic riding program; 2) extend the operating hours on Tuesday through Friday from 10AM-5PM to 9AM-5PM or sunset, whichever is earlier; and, 3) expand the number of existing off-street parking along Narcissa Drive from 10 parking spaces to 20 parking spaces.
