REVISION TO CONDITIONAL LARGE DOMESTIC ANIMAL PERMIT NO. 2 (CASE NO. ZON2016-00465): A request to 1) extend the existing Conditional Large Domestic Animal Permit No. 2 for seven additional years marking the new expiration date as of December 19, 2023 to continue the operations of the "Ride-to-Fly" therapeutic riding program; and, 2) extend the operating hours on Tuesday through Friday from 10AM-5PM to 9AM-5PM or sunset, whichever is earlier.
